- Nomination papers must be delivered to the Returning Officer, Lynton House, Commercial Road, Barnstaple, Devon, EX31 1DG Monday to Friday between 10am and 4pm after the date of this notice but no later than 4 pm on Wednesday, 3rd April 2019.
- If any election is contested the poll will take place on Thursday, 2nd May 2019.
- Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Lynton House, Commercial Road, Barnstaple, Devon, EX31 1DG by 5 pm on Monday, 15th April 2019.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Lynton House, Commercial Road, Barnstaple, Devon, EX31 1DG by 5 pm on Wednesday, 24th April 2019.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Lynton House, Commercial Road, Barnstaple, Devon, EX31 1DG by 5 pm on Thursday, 2nd May 2019. The physical incapacity must have occurred after 5 pm on Wednesday, 24th April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 24th April 2019.
